

VAUXHALL SALES EVENT – FULL TERMS AND CONDITIONS

The Promotion is subject to the following terms and conditions (the “**Terms**”) between you (“**You**”) and Vauxhall Motors Limited (“**Vauxhall**”).

TERMS AND CONDITIONS

1. The Promotion is available on new Vauxhall models only (the “**Qualifying Vehicle**”).
2. The Promotion is a discount of £1,000 (inc. VAT) off the On-The-Road (“**OTR**”) of the Qualifying Vehicle (the “**Promotion**”).
3. The Promotion applies to orders between 8th May to 31st May 2026 and registrations by 30th June inclusive (“**Promotional Period**”).
4. The Promotion applies to private individuals (18+) only and cannot be used in conjunction with Motability, Fleet, Business sales.
5. The promotion is available at participating Vauxhall retailers only (excluding Arnold Clark).
6. To receive the Promotion, you must be a UK resident.
7. The Promotion cannot be used in conjunction with other Promotions provided by Vauxhall.
8. The Promotion excludes pre-registered vehicles.

9. To receive the Promotion, you must order a Qualifying Vehicle between the Promotional Period. The Promotion applies to qualifying new retail sales only.
10. You are responsible for any additional charges incurred as a result of travelling to the participating retailer.

18. These Terms shall be governed by and construed in accordance with the laws of England and Wales. The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to deal with any dispute or claim that arises out of or in connection with these Terms and the Promotion.
